#### What is Deafblindness?

Deafblindness is a condition in which both a hearing and vision loss are present at the same time. The combined effects of these losses, even if both are mild, create unique challenges for the child, family & educator.

- In the United States deafblindness affects more than 10,000 children between birth and 22 years of age
- Deafblindness has more than 70 known causes.
- The student does NOT have to be labeled as deafblind in accordance with LA Bulletin 1508 (Pupil Appraisal Handbook) to be eligible for inclusion in this Project.

# My student/child is classified as having multiple disabilities — not deafblind. Would he/she be eligible for services?

A. Yes. Regardless of the student's exceptionality, the student may be eligible for services if he/she meets the criteria listed under "Who is eligible?".
